

Pastor's Report for 2008

Whereas 2007 was a year of moving forward as a church and restructuring, 2008 was a year of stopping, reflecting, mourning, and evaluating. In all sadness we lost a significant amount of members compared to years past, mostly to their passing on to be with our Lord, but others by transfer. Personally I felt like God was stretching me and my role as a Pastoral Care giver, which is not one of my spiritual gifts, but I felt privelged to serve and support people who lost loved ones. We need to celebrate our church giving a significant amount of funds and time in service in our community. Again, we participated in Sharefest, support the Portage Food Pantry, the Portage Resale Shop, First Contact, three missionary families and a host of other local and global mission projects. We also gave support to By the Hand ministry in Chicago and enjoyed the By the Hand kids choir this summer.

In the office we introduced a new copier to our technological arsenal and Dan Fabbri and I installed a network server so that our office computers can share printers, documents, exchange email, and calendars.

2008 Annual Report Board of Deacons

The Deacons consisted of 11 members for the 2008 year. Debby Bailey and Cheryl Engel served as co-moderators. Julia Hoham served as clerk, David Harbaugh was are liason between Deacons and Session and Eric Baggett represented the Deacons on the nominating committee.

Our constitution is very clear as the roll of Deacons. The primary function of a Deacon is to minister to those persons in need or in distress. This function is intentionally very broad so it may encompass service to any person in need anywhere. No limits of location or categories of need exist. The sick and the friendless are specifically mentioned, but the Deacons service is not limited to these two groups. Deacons are to minister to any who may be in distress.

The Deacons of ODCC sought to do this in the following ways:

- Get Well, Sympathy and Concern cards were faithfully sent to members and friends of the congregation.
- Altar flowers were delivered to shut-ins
- Hospital, nursing home and home visits were made throughout the year
- Assistance was given for funeral services conducted at the church
- Pink envelopes continued to be inserted in the bulletin the first Sunday of each month with a total donation of over \$3400 being given to the Portage Food Pantry. In addition, the Deacons gave an additional \$300
- A \$200 donation was made to the Northwest Indiana Food Bank
- Our annual packing of "care" packages to our college students were sent out during finals weeka total of 12 boxes were warmly received
- The Deacons hosted a breakfast in June with a great turnout
- Two Saturdays were spent by some at the Portage Resale Shop and also the City wide Share Fest included members from the Deacons helping to clean a home in Lake Station that was flooded
- The annual church picnic was planned & hosted in August. "Kids by the Hand" visited our church that Sunday & stayed for this fellowship time at the picnic. The Deacons also made a \$200 donation to this group.
- The Deacons hosted a "Family Day at the Ballgame" in August with 29 in attendance to the game.

- The Deacons purchased 200 note cards which featured a painting of our church done by artist Jack Simmerling. These were sold as cards & framed pieces and monies made were used to purchase 2 Water Buffalo through Heiffer International.
- 20 names were received from the Portage Township Trustee office and the annual "Angel Tree" was put up and gifts received from the congregation.
- A \$125 donation was made to "Operation Christmas Tree" for small decorated trees to be sent to service people in Iraq.
- Hilton Corporation donated towels to not-for-profit organizations. Over 300 pounds of towels were picked up and given out to clients from Meals on Wheels in Portage. Also Sojourners & Tri-City Mental Health received this gift.
- The Deacons helped with the greening of the church.

Many thanks to the congregation for supporting the Deacons and our projects. Through your help we had a successful year.

Mission Committee 2008 Report

The Mission Committee is pleased to report on Mission projects for 2008 which were equally divided between International, National and Regional ministries. In addition to providing financial support, Mission teams completed many regional and international ministry projects.

International Mission projects included support for Jim and Linda Crouch with Kent Academy in Nigeria, Tom and Dora Becker in Czech Republic, Campus Crusade to provide 5,000 meals to the starving in Zimbabwe, Campus Crusade to provide Bibles for spiritually needy in Sudan, Gideons to provide Bibles to international missions, and Judy Selund to help Habitat for Humanity build houses for homeless in Malawi.

National Mission projects included support for Brad Harry with Chicago urban ministry, Agape Community Shelter with outreach school suppliers and Thanksgiving boxes of love, United Way with clean-up supplies for food victims in Southern Indiana, sponsorship of one child in By the Hand Club for Kids inner city development program, Presbyterian Frontier mission projects, Christian Haven for building an athletic facility for at risk young men, and Walter Reed Army Medical Center to care for wounded soldiers.

Workshop

ODCC hosted a free marriage seminar titled, "Til Death Due Us Part... Saving Your Marriage and Relationship." It was held in the sanctuary on September 14, 2008. Roy Thomas, LCSW, from Samaritan Counseling Center, led this very thorough and informative seminar. Topics included how to regain love in your marriage and relationship; challenges and cures for the young couple and marriage; challenges and cures for the aging marriage and relationship; and marriage, the church and the bible.

Property Committee Annual Report 2008

As my first year on the property committee ends, I must first and foremost thank all those who have helped with the committee's responsibilities. The committee members, David Harbaugh, Butch Kleweg, Gordon Johnson, Dean Squire and Tom Woodward have worked through the many problems presented to us. The advice of Rich Nagy and Duane & Lee Hibbs particularly in scheduling the maintenance tasks over the past year has helped keep the facility up to the high level we have come to expect. I am grateful to the wisdom from the many years that has helped guide me. Much of the grounds maintenance was covered by the Engels with Matt as the strong young back and Ken & Cheryl provided great assistance as part of the work crew.

We were lucky to avoid any major equipment failures this year. This is a testament to those who have worked so diligently in past years planning for the church use and maintaining the systems. Most of our efforts this year were on maintenance and minor repairs. Beginning in 2008, the budget includes a capital expense fund to accrue funds for the unexpected major repairs which have been increasing in number the past few years as our building ages. A good year like this past year may allow us to replace and upgrade some equipment before the next failure.

The most interesting thing I have learned as an elder on the property committee this year is that the work of the property committee is so much less with the property than with the people of the church. Providing positive experiences for people to worship or work, or engage in any activity at the church is a goal of our committee. The property committee focus is on making sure the physical equipment and environment of the church contributes to each person's positive experience and does little to create a negative impact. Many times it is the positive interaction with fellow church members that makes this happen. All of this works together to facilitate this community to grow in its discipleship in Jesus Christ.

2008, Stewardship Committee

The Committee started the year with veteran members, Allen Johnson, Deana Lecy, Al Mussman, and Walter Sampson. An effort was made by those members to recruit more members. By June, Jane Dickey, Ken Engel, and Nancy Johnson had joined. It was a busy year, with recurring and new issues that were dealt with. All the members were helpful, valuable, and necessary for the tasks at hand and will be of value in 2009.

The committee oversaw the transfer of insurance providers from Guide One to Church Mutual. This saved the Church about \$1,000 while providing equal, and indeed slightly enhanced coverage.

In the second half of the year, three attempts were made by unknown persons to defraud the church by presenting unauthorized checks or electronic withdrawal notices. All were unsuccessful and under Allen Johnson's supervision a new checking account was set up with a security system that allows our office staff to review checks or notices for withdrawal before they are paid. This challenge has presented us with the opportunity to better our practices and internal security efforts and cost us very little except for a good deal of Allen's time. Local law enforcement is updated and involved, though the likelihood of catching or prosecuting anyone is miniscule. Prayers should be offered for the people involved.

A positive issue with which we dealt was the presentation of an unplanned, undesignated gift of cash for \$25,000. Session asked the committee to recommend a plan for use of this gift and future gifts like it. We did, recommended a plan to session, and they approved it. The policy is attached under separate cover.

Regarding the work of the Annual Campaign and fund raising for the annual budget, the committee decided again to use the Consecration Sunday model. The positive thing about the approach is that it gets lots of members involved in the process. For the first time we asked church leaders to lead the way as "advanced pledgers." This was suggested by our guest leader Ray Fancher who is the current executive Presbyter of the Wabash Valley Presbytery. The advanced mini-drive was good in that it allowed the leaders to show leadership, a very necessary thing this year. As of this writing we have 76 pledgers (2 less than last year) for a total of \$190,742 (\$12,435—6% less than last year). With the extraordinary circumstances in the overall economy considered, we believe these numbers are analogous to a glass extremely half full.

Also regarding the annual pledges, the Session approved a whole new concept for our church: a three person Pledges Pastoral Committee which would consist of the chair of the Stewardship Committee (President of the Corporation), the Treasurer of the Corporation, and the Chair of the Annual Campaign drive. This small group would share the burden of knowledge regarding the congregation and its giving patterns, amounts and issues. It would have the ability and responsibility of sharing issues with the pastor if it felt there might be a pastoral issue reflected in

the giving of a family. The knowledge of this group would be held in strict confidence, but carried with our belief that how we spend our money is a sure reflection of spiritual health.

That said, there are five consistent pledgers form recent years whose average pledges per family amount to almost \$2,000 and who we have not heard from. The Pledges Pastoral Committee will be considering this situation and wrestling with whether to pass the knowledge to the pastor and how/if to reach out to these families.

When the Stewardship Committee proposed a budget to Session, we were aware of how well all the committees did in managing their budgets this year. We felt we would be more blessed than most non-profits or businesses if planned spending was not slashed and could continue to reflect the values of our congregation. In other words we felt that to hunker down because it was a rainy day would be not "letting our light shine." The budget for 2009 does not show any cuts. Rather it showed slight increases in the areas most important to us: supporting the people in our midst who support us ("Personnel") and supporting people in our midst who can really use our help ("Mission"). Attached is the accepted budget for 2009 and, "Advise and Recommendation for 2009 Budget" dated Dec 6,2008.

The Corporation and Endowment have liquid assets sufficient to keep us going through a season of rainy days (see the current financial statements attached). Many of those assets are in the form of individual stocks. In 2008 the Corporation often had only enough cash to get us through a couple of weeks of expenses, while the Endowment has over \$30,000 in cash, with no consistent expenses. Part of the reason for this is that stock has been given in the past to satisfy pledges. Now the policy regarding gifts of stock is, "At the time of a gift of stock, the Committee shall meet within 10 business days and decide whether the stock, based on its merits as an investment and based on the current need for cash, should be held or sold."

Aspects of stewardship that have not received the focus they might are passing on our gifts of time and talent...as well as treasure. Also, some type of automatic checking account or credit card withdrawal is an opportunity that was discussed but not acted upon this year.

I think I can speak on behalf of the whole Committee when I say, there were challenges that presented themselves, we sought out chronic issues which needed to be wrestled with, and unexpected blessings and angels showed up in our work and our meetings. It was an honor and privilege to be involved. Much was achieved. Much needs to be done. We pray for God's continued blessings,

WORSHIP COMMITTEE

COMMITTEE MEMBERS: Laura Hannon (elder), Rev. Leach, Libby Larson, Jayne Mann, Mark Lecy, Dan Fabbri, Margo Hartman and Bob Hartman.

WORSHIP ATTENDENCE: The average attendance for both services for the 52 weeks was 106 per Sunday. The first service averaged 38 per Sunday. The second service averaged 68 per Sunday. These numbers included; worship leaders, choir members, musicians, directors and guests (Girl Scouts and "By the Hand Kids Club). For some reason attendance was not taken at 2 first services and 1 second service. During the summer (June 15 to August 31) First Service averaged 51 per Sunday and Second Service averaged 54 per Sunday for a total average of 105 per Sunday.

SUMMER SCHEDULE: The summer schedule was adjusted to have the Second Service begin at 10 A.M. instead of 10:45 A.M. Worship Committee felt that there might be at least two advantages in making this change: The early dismissal of second service attendees would provide more family time for activities and the thirty minutes might provide more fellowship time together for those who attend different services. Those attending first service were encouraged to stay after the service for refreshments and those attending the second service were encouraged to come thirty minutes before worship to visit with the first service attendees. All of this was done to take advantage of the suspension of Sunday School during the summer months. We believe that this schedule was generally well received by all. Our thanks to the committee members who made sure that the congregation was properly informed in order to minimize confusion. The schedule was in effect from June 15 to August 31.

SPECIAL SERVICES: Maundy Thursday with 53 in attendance and Christmas Eve with 134 in attendance.

PULPIT SUPPLY: In the absence of Rev. Leach the pulpit was filled Rev. Nancy Mockros, Rev. Phil Smith, Pastor Mike Becker, and Elders Al Mussman and Chuck Smothermon.

COMMUNION SERVICES: In addition to the 12 Communion Sundays, Communion was served at the March 20 Maundy Thursday Service. Our thanks to Gordon Johnson and Barbara Scully for serving communion to shut-ins, also to Laura Hannon for securing servers as well as those who prepared the elements.

SANDPIPER COOPERATIVE PRESCHOOL

Sandpiper Cooperative Preschool is 35 years old this year. The preschool serves 3, 4, and 5 year olds from Ogden Dunes and the surrounding communities. Our current enrollment is seven children. They attend preschool on Mondays, Wednesdays and Fridays.

The mission of Sandpiper is to offer a nurturing environment that is designed to help enhance the child's self-image, further develop positive socialization skills, and strengthen concept formation and motor skills. We accomplish this by following a daily schedule that is enhanced with age appropriate activities which are set in a welcoming, print rich, learning environment. This school year, the classroom is set up a little bit differently. There are added interest areas and all the areas are more defined. We have added an art/writing area, a fine motor skills area, and a word wall. We have enriched the block and house areas with more materials. We are most proud of the reading area which has become cozy and inviting by the addition of a rocking chair, beanbag chair and a library display shelf. All of these changes would not have been possible without the support of parents, friends and church members. Our curriculum is a literacy based program in which reading, letter recognition, language and vocabulary are all a part of every school day. Our daily schedule includes small group times for both the pre-k children and the 3 and 4 year olds. In 2008 the children participated in 8 sessions of kindermuzik. We had 2 field trips scheduled; the apple orchard and the pumpkin patch. Coming up in early 2009 we have plans for a visit from the HealthWorks Kids Museum in which the children will become super heroes and learn about healthy foods. We also will be going on a field trip to the grocery store.

My personal goal at Sandpiper is to have each child leave school wanting to come back.

The Sandpiper board is made up of volunteer parents who work together with the teacher to provide a meaningful experience for the children. The funding for the preschool comes primarily from tuition paid by the parents of the students. The majority of the expenses are the teacher's salary, materials and supplies, rent for our classroom space and insurance. Sandpiper families held two fundraisers this past fall and winter; photos on the beach through Alderson Photography and a cookie dough sale. The Ogden Dunes Women's Club also made a generous donation which was very much appreciated.

The preschool uses the southwest corner of the building for morning classes and the room is shared with other church-related activities throughout the rest of the week.

We thank you for your continued support of this important children's program.

Endowment Annual Report 2008

The Trustees for 2009 were Al Mussman, Allen Johnson, Carolyn Saxton, Robert Leach, and Deana Lecy, replacing Bob Hartman. It was a group that had experience in the Church and non-profits in general. There were two new major issues that represented new ground for the Endowment and the Church.

First, was the very idea that we are blessed with accumulated wealth, and the question that was begging to be asked therefrom was, "Are we using God's blessings in our charge in a way that fit our values—our **Christian** values?" We decided that some of our accumulated earnings ought to be used by the greater church and community in accord with the Trust Agreement. With Sessions approval, we adopted the attached"Policies and Procedures for Distribution of Income." Minutes from the granting meeting and applications for grants are on file in the church offices. There was \$4,700 available to be granted and the recipients were as follows:

Sandpiper Pre-school: \$2,000

The Church/Education Committee: \$1,500

The Portage Resale Shop: \$ 600

Portage High School Natural Helper Program \$ 600

Regarding the second major issue I will quote the Stewardship Annual Report: "A positive issue with which we dealt was the presentation of an unplanned, undesignated gift of cash for \$25,000. Session asked the committee to recommend a plan for use of this gift and future gifts like it. We did, recommended a plan to session, and they approved it. The policy is attached under separate cover."

The Church financial statements contain a balance sheet of the Endowment and should be attached to this report. Again I'd like to duplicate the wording of the Stewardship Report: "The Corporation and Endowment have liquid assets sufficient to keep us going through a season of rainy days (see the current financial statements attached). Many of those assets are in the form of individual stocks. In 2008 the Corporation often had only enough cash to get us through a couple of weeks of expenses, while the Endowment has over \$30,000 in cash, with no consistent expenses. Part of the reason for this is that stock has been given in the past to satisfy pledges. Now the policy regarding gifts of stock is, 'At the time of a gift of stock, the Committee shall meet within 10 business days and decide whether the stock, based on its merits as an investment and based on the current need for cash, should be held or sold." It is the opinion of the chair that this whole situation in general presents a challenge that could be resolved in the coming year.

Lots of new ground was broken in 2008 and the Trustees never met without the realization that all our blessings are from God. Whether the financial assets of which we are stewards show up on the Corporate "books" or Endowment "side", they are gifts that the Church as a whole is endowed with and over which Session thereby has say.
